BDRK continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 02, 2024, September 12, 2024, September 22, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

BDRK is engaged in the business of trading of agriculture commodities and also provides commission agents services to its customers. The firm mainly deals in barley, castor seeds, coriander, cotton bales, mustard seeds and wheat etc. It procures the agriculture commodities from the local mandis as well as from farmers and sells those to different customers directly as well as through distributors. BDRK is also engaged in the business of land development business.
