## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated October 19, 2023, placed the rating(s) of K C Timber Traders (KCTT) under the 'issuer non-cooperating' category as KCTT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KCTT continues to be non-cooperative despite repeated requests for submission of information through emails dated September 03, 2024, September 13, 2024 and September 23, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

New Delhi based K C Timber Traders (KCTT) is a partnership firm established in April, 1997. The firm is managed by partners, Mr. Manish Bansal and Mr. Romesh Bansal. The firm is engaged in trading of timber logs.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of KCTT into Issuer Not Cooperating category vide press release dated July 17, 2024 on account of its inability to carry out a review in the absence of requisite information.
