Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 24, 2023, placed the rating(s) of Prayag Polytech Private Limited (PPPL) under the 'issuer non-cooperating' category as PPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 09, 2024, October 19, 2024 and October 29, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company was incorporated in August, 1982 under the name of R.B.M. Internationals Private Limited. The name of the company was changed to Prayag Polytech Private Limited on June 27, 1994. The company is engaged in manufacturing and export of masterbatches, which are available in granular form, are used for coloring and enhancing properties of plastics by mixing them with raw polymer during the plastic manufacturing process.
