### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 13, 2023, placed the rating(s) of Nashik Waste Management Private Limited (NWMPL) under the 'issuer non-cooperating' category as NWMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NWMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 28, 2024, September 07, 2024 and September 17, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings for NWMPL have been revised on account of non-availability of requisite information.
