Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 27, 2023, placed the rating(s) of Sterling Cast and Forge (SCF) under the 'issuer non-cooperating' category as SCF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 12, 2024, October 22, 2024 and November 01, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sterling Cast and Forge (SCF) was established in April, 2010 as a partnership firm with Mr. Subash Chander and Mrs. Anjana Shoor as its partners sharing profits and losses equally. The firm is engaged in manufacturing of hand tools such as spanners, hammers, pliers, wrenches etc at its manufacturing facility located in Jalandhar, Punjab.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SCF into 'Issuer not-cooperating' category vide press release dated May 28, 2024 on account of non-availability of requisite information from the company.
