Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 03, 2023, placed the rating(s) of Mahalaxmi Oil Mill (MOM) under the 'issuer non-cooperating' category as MOM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MOM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 18, 2024, August 28, 2024, September 07, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

MOM is a partnership firm engaged in manufacturing maize oil and maize oil cake used as cattle feed. The partners of the firm are Mr Mansukh Bhagat (65% share), Mr Premchand Patel (15% share), Mr Hitesh Patel (10% share) and Mr Manoj Velani (10% share). The manufacturing facility of the firm is located in Dhansura Taluka of Gujarat with an installed capacity of 100 tonnes crushed per day (TCD). MOM sells its product variants under the brand name of 'Mewad King'.
