Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 06, 2023, placed the rating(s) of Vanita Cold Storage (VCS) under the 'issuer non-cooperating' category as VCS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VCS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 21, 2024, October 01, 2024 and October 11, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

It is engaged in export of sea foods mainly croaker fish, ribbon fish, squid, cuttlefish, shrimps and pomfrets primarily to countries in Middle East, China, Europe and Africa. The firm derives majority of revenue from China. The firm has a processing facility at Veraval.
