## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 10, 2023, placed the rating(s) of Gem Motors India Private Limited (GMIPL) under the 'issuer non-cooperating' category as GMIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GMIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 25, 2024, September 04, 2024, September 14, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Gem Motors India Private Limited (GMIPL) was incorporated in the year 2007 by Mr. Raju Yadav Erragudla and family. GMIPL is an authorised dealer of Maruti Suzuki India Limited (MSIL) for vehicles and spare parts. It has five operational showrooms and six workshops in Telangana. The company purchase the vehicles and spare parts directly from MSIL's manufacturing units in Gurugram, Haryana. The registered office is located in Kondapur, Telangana.

**Status of non-cooperation with previous CRA:** India Ratings has continued the rating assigned to the bank facilities of GMIPL into Issuer Not Cooperating category vide press release dated May 15, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
