# Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 24, 2023, placed the rating(s) of Om Satya Overseas (OSO) under the 'issuer non-cooperating' category as OSO had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OSO continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 09, 2024, October 19, 2024 and October 29, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Om Satya Overseas was established as a partnership firm in 2013. However, the operations started in August 2015. It is currently being managed by Mr. Ajay Kumar Gupta and Mr. Ravi Kumar Gupta. The firm is engaged in processing of paddy at its manufacturing facility located in Karnal, Haryana.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of OSO into Issuer Not Cooperating category vide press release dated March 18, 2024 on account of its inability to carry out a review in the absence of requisite information.
