### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 17, 2023, placed the rating(s) of Shree Hardeo Industries (SHI) under the 'issuer non-cooperating' category as SHI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SHI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 01, 2024, September 11, 2024, September 21, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the firm

Established in the year 2013, Shree Hardeo Industries (SHI), is a proprietorship firm based in Raipur, Chattigarh. SHI is engaged in the manufacturing of PVC pipes, column pipes and PVC fittings. The firm commenced manufacturing operations from Sep 2013 and has an annual installed capacity of 1000 Metric Tonne / annum. The project was set up at a cost of Rs 14.50 crore, funded by a term loan of Rs 6.25 crore and capital of Rs 8.25 crore. Product portfolio of the firm includes SWR pipes and fittings, column pipes, plumb pipes, casing pipes, UPVC pipes, which are sold under the brand name of 'Vertex' SHI procures raw material, which includes PVC resin and other chemicals from suppliers based in Chattisgarh and others. The finished products are sold to traders and other associate entities, through a distribution network.
