### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated November 30, 2023, placed the rating(s) of S. R. Seth & Sons (SRSS) under the 'issuer non-cooperating' category as SRSS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRSS continues to be non-cooperative despite repeated requests for submission of information through emails dated October 15, 2024, October 25, 2024 and November 04, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The firm is currently managed by Mr. Sunit Seth & Mrs. Mukta Seth sharing profit and losses equally. The firm is engaged in the trading of electric motors, pumps, alternators, DG sets, transformers and electric goods to traders and manufacturers across various industries based in PAN India.

**Status of non-cooperation with previous CRA:** Acuite (SMERA) has continued the rating assigned to the bank facilities of SRSS into Issuer Not Cooperating category vide press release dated July 22, 2024 on account of its inability to carry out a review in the absence of requisite information.
