Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 11, 2023, placed the rating(s) of Vishal Arogya Sampat Private Limited (VASPL) under the 'issuer non-cooperating' category as VASPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VASPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 27, 2024, August 06, 2024, August 16, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of VASPL have been revised on account of non-availability of requisite information.

The company has been promoted by Mr. Sridhar Rao (Managing Director) and Ms. G. Anuroopa. VASPL is engaged in distribution of food products, health care products as well as personal care and household products. The company is sole distributor of products of Patanjali Ayurvedic Limited (PAL), Divya Pharmacy and Divya Yog Mandir (Trust) in Andhra Pradesh and Telangana.
