Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 03, 2023, placed the rating(s) of Dudi and Company (DC) under the 'issuer non-cooperating' category as DC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 18, 2024, August 28, 2024, September 07, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Bikaner (Rajasthan) based Dudi and Company (DC) was formed in 1996 as a partnership concern. Subsequently, there were changes in the partnership on April 2005 and currently, there are six partners in the firm. DC is engaged in execution of contracts related to road construction. It is registered as an AA class (highest AA class to lowest D) approved contractor from Public Work Department (PWD), Rajasthan, Rajasthan State Road Development Corporation (RSRDC) and Rajasthan Agriculture Marketing Board (RAMB).

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of DC into Issuer Not Cooperating category vide press release dated March 05, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.

CRISIL has continued the rating assigned to the bank facilities of DC into Issuer Not Cooperating category vide press release dated December 08, 2023 on account of its inability to carry out a review in the absence of the requisite information from the firm.
