### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 25, 2023, placed the rating(s) of Kuber Tubes and Fittings Private Limited (KTFPL) under the 'issuer non-cooperating' category as KTFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KTFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 10, 2024, August 20, 2024, August 30, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in March 2013, Kuber Tubes & Fittings Private Limited (KTFPL) was promoted by Mr. Sanjib Bhattacharya and Mr. Mintu Das for setting up a manufacturing plant for galvanised pole, pipes and fittings. The plant was set up funded by the promoter's fund only and the company commenced its operations in March 2017. The plant has an installed capacity of 27,600 metric ton per annum.
