Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 31, 2023, placed the rating(s) of Agarwal Toughened Glass India Private Limited (ATGIPL) under the 'issuer non-cooperating' category as ATGIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ATGIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 15, 2024, September 25, 2024 and October 05, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Jaipur-based (Rajasthan) Agarwal Toughened Glass India Private Limited (ATGIPL) was incorporated in October, 2009 by Mr. Uma Shankar Agarwal and Mr. Mahesh Kumar Agrawal with an objective to set up a greenfield project for manufacturing of toughened glass (single and double glazed) at Jaipur. CARE does not have any update on the latest developments in this regard.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of ATGIPL into Issuer Not Cooperating category vide press release dated December 18, 2023 on account of its inability to carry out a review in the absence of requisite information.
