Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 05, 2023, placed the rating(s) of Essem Enterprise (EE) under the 'issuer non-cooperating' category as EE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. EE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 20, 2024, August 30, 2024, September 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

Kolkata (West Bengal) based Essem Enterprise (EE) was established as proprietorship entity in the year 1985 by Mr. Santanu Mukherjee. Since its inception, the entity has been engaged in civil construction activities in the segment like construction of road, bridges, water drain, box culvert and buildings. Along with civil construction activities, the entity has also been engaged in allied electrical, underground pipeline and mechanical jobs. The entity participates in tenders and executes orders for the Indian Railway, Kolkata Municipal Corporation, Hindustan Aeronautics Limited etc.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of EE into ISSUER NOT COOPERATING category vide press release dated October 07, 2024 on account of its inability to carry out a review in the absence of requisite information from the firm.
