### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 31, 2023, placed the rating(s) of Magadh Construction Works (MCW) under the 'issuer non-cooperating' category as MCW had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MCW continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 15, 2024, September 25, 2024, October 05, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the firm

Magadh Construction Works (MCW) was established during 1984 in Gaya, Bihar. MCW is a relatively small sized Bihar based firm engaged as a Government's Registered Civil works contractor. The firm works for Government agencies like Road Construction Department, Public Works Department of Bihar etc. The day to day operations are looked after by Mr. Ram Naresh Sharma, Managing Partner, along with other five partners and a team of experienced personnel.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of MCW into Issuer Not Cooperating category vide press release dated June 17, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.

India Ratings has continued the rating assigned to the bank facilities of MCW into Issuer Not Cooperating category vide press release dated July 14, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.
