Industries (PKI) under the 'issuer non-cooperating' category as PKI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PKI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 04, 2024, September 14, 2024, September 24, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The firm is ISO 9001: 2008 certified entity and it is engaged into the business of manufacturing of power and distribution transformers. PKI manufactures transformers from capacity of 5 Kilo Volt Ampere (KVA) to 5 Mega Volt Ampere (MVA) and supplies the same to State Electricity Boards (SEB's) in Madhya Pradesh and Rajasthan and other private customers who take contract from government departments.
