Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 15, 2023, placed the rating(s) of Aastha Society (AS) under the 'issuer non-cooperating' category as AS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 30, 2024, October 10, 2024 and October 20, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to bank facilities of AS have been revised on account of non – availability of requisite information.
