# **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated November 08, 2023, placed the rating(s) of Kishan Lal Agrawal Contractor (KLAC) under the 'issuer non-cooperating' category as KLAC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KLAC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 23, 2024, October 03, 2024, October 13, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Since its inception, the firm has been engaged in civil construction business like laying of pipelines, supplying and fixing C.I. Pipe Line, construction of water supply system, construction of stadium building, residential quarters, college, shopping complex, etc. KLAC participates in tenders and executes orders for the various departments of Government of Chhattisgarh. KLAC is classified as a 'Class A contractor' by the Government of Chhattisgarh which enables it to participate in higher value contracts.
