Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 27, 2023, placed the rating(s) of Anjani Food Products Private Limited (AFPPL) under the 'issuer non-cooperating' category as AFPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AFPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 11, 2024, November 21, 2024 and December 01, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings have been revised on account of non-availability of requisite information.
