### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 03, 2023, placed the rating(s) of IQ City Foundation (ICF) under the 'issuer non-cooperating' category as ICF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ICF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 18, 2024, September 28, 2024, October 08, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the society

IQ City Foundation (ICF), set up in February 2006 and erstwhile known as SPS Synergy Foundation was initially jointly promoted by the SPS, Mani and Synergy group of Kolkata. However, with the exit of the SPS group from the promoter's consortium, the society was subsequently renamed in April 2014. ICF is a registered society under the West Bengal Societies Registration Act, 1961 and has been formed for the purpose of establishing and operating hospital and educational institutions. ICF, a part of Mani Group, has set up a Medical College and a Teaching cum multi-speciality Hospital (under the name IQ City Foundation) at Mouza Sovapur in Durgapur, West Bengal on a 100 acres parcel of land allotted to it by Govt. of West Bengal.

**Status of non-cooperation with previous CRA:** Infomerics has moved the rating assigned to the bank facilities of ICF into ISSUER NOT COOPERATING category vide press release dated November 22, 2024 on account of its inability to carry out a review in the absence of requisite information from the society.
