### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 10, 2023, placed the rating(s) of Pavan Traders (PT) under the 'issuer non-cooperating' category as PT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 25, 2024, October 05, 2024, October 15, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

# **About the Firm**

Anantapur based (Andhra Pradesh), Pavan Traders (PT) was established in 2013 as a proprietorship firm by Mr. G. Prabhakar. PT is engaged in the processing and distribution of Bengal Gram. The firm purchases Bengal Gram from the farmers located in Andhra Pradesh and Karnataka. The firm engages into cleaning of mud, straw and distribute the final product to the customers (Dal Millers) located in Tamil Nadu, Karnataka, Kerala, Andhra Pradesh and Maharashtra. The firm has around 300 customers all over the India and 60 per cent of the revenue is being generated from Tamil Nadu state region only. The current installed capacity for processing of Bengal Gram is 60 tons per day.
