Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 22, 2023, placed the rating(s) of Vedasri Green Energy Private Limited (VGEPL) under the 'issuer non-cooperating' category as VGEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VGEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 07, 2024, October 17, 2024 and October 27, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

VGEPL is a Special Purpose Vehicle (SPV) incorporated for setting up a 2.2 MW solar project at Bidar district, Karnataka and became operational in January 2017. Ms. Sridevi G Tonne and Mr. Prakash Tonne are the managing directors of the company and Mr. Avinash M Yeoliker & Mr. Kavindra Avinash Yeoliker are other directors of the company. Ms. Sridevi was allotted 2.2 MW solar project under the 1-3MW Farmer Solar Scheme by the Karnataka Renewable Energy Development Energy Limited (KREDEL) and a Power Purchase Agreement (PPA) was signed with Mangalore Electricity Supply Company Limited (MESCOM). The PPA was signed with a tariff rate of Rs. 8.4 per kWh for a period of 25 years. M/s Aditya Green Energy Pvt Ltd was appointed as the EPC contractor for installation of the power plant.
