### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 12, 2023, placed the rating(s) of Airtravel Enterprises India Limited (AEIL) under the 'issuer non-cooperating' category as AEIL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AEIL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 27, 2024, November 06, 2024, November 16, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

AEIL is a Trivandrum-based company engaged in the business of air ticketing services, cargo (sea & air) clearing & forwarding (customs clearance), hospitality and travel-related services like visa processing, travel insurance, currency exchange, itinerary planning, car rentals, and railway bookings. The company is registered with the International Air Transport Association (IATA). AEIL belongs to the Airtravel Enterprises Group, promoted by Mr. E.M. Najeeb. The group has presence in tours and travels, information technology, real estate, advertising, media, healthcare and hospitality. AEIL was originally established in the year 1976 by Mr. E.M. Najeeb as a partnership firm. The firm was converted into a private limited company in the year 1984 and subsequently to a closely-held public limited company in 1995.
