### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 05, 2023, placed the rating(s) of Jai Mata Di Ginning And Pressing Factory (JMDGPF) under the 'issuer non-cooperating' category as JMDGPF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JMDGPF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 20, 2024, October 30, 2024 and November 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
