### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 28, 2023, placed the rating(s) of Maruti Fertochem Private Limited (MFPL) under the 'issuer non-cooperating' category as MFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 12, 2024, November 22, 2024 and December 02, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The group has its presence in poultry farming, fertilizers, bio-technology, infrastructure and education sectors. MFL commenced operations in 1994 and is engaged in manufacturing of granular NPK (Nitrogen, Phosphorous and Potassium) fertilizers. Apart from these products, MFL also offers organic fertilizers/ soil conditioners and neem-based pesticides, 'Maruti- Max', which provides micronutrients to crops during growth phase.
