Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 26, 2023, placed the rating(s) of Lalitha Metals (LM) under the 'issuer non-cooperating' category as LM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 10, 2024, September 20, 2024 and September 30, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Lalitha Metals (LM) was incorporated in 1976 by Mr. A. Krishna Balaji and Mr. A V K Chowdary. The firm is engaged in the business of manufacturing of Spheroidal Graphite Iron (SG Iron) castings which include cast iron and non-ferrous castings, valves, pipe fittings and manhole covers.

Status of non-cooperation with previous CRA: Brickwork has continued ratings of LM to 'Issuer Not Cooperating' category vide press release dated April 03, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.
