Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 18, 2023, placed the rating(s) of Gayatri Cotton Mills (GCM) under the 'issuer non-cooperating' category as GCM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GCM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 02, 2024, November 12, 2024, November 22, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Gayatri Cotton Mills (GCM) was established in June 2012 as a partnership firm by Mr. Innamuri Basavaiah and Mr. Innamuri Subrahmanyam. The firm is engaged in manufacturing and processing of Kappas into cotton lint. The firm has its facilities (14 ginneries and 1 cotton baling press) located at Guntur District of Andhra Pradesh. The firm acquires cotton directly from the farmers and after ginning, sells the same in the domestic market.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of GCM to the 'issuer not-cooperating' category vide press release dated May 15, 2024 on account of its inability to carryout review in the absence of requisite information from the firm.
