### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 14, 2023, placed the rating(s) of Sri Ram Enterprises\_(Visakhapatnam) (SRE) under the 'issuer non-cooperating' category as SRE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 29, 2024, November 08, 2024, November 18, 2024 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

SRE has two restaurants located in 3 CARE Ratings Limited Press Release Gajuvaka, Vishakhapatnam in the name of "Best Western Ramachandra Hotel" and "Ramachandra Ridge".
