Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 20, 2023, placed the rating(s) of Premierworld Technology Limited (PTL) under the 'issuer non-cooperating' category as PTL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PTL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 04, 2024, September 14, 2024 and September 24, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

PTL: (erstwhile Premier Irrigation Equipment Ltd) was promoted by Late Mr. Kedar Nath Goenka. In 1989, the company started commercial production of fountains and installation of fountains for beautification purpose (mainly for government contracts). In 1999, it started manufacturing hydraulic and pneumatic ride simulators.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of PTL into Issuer Not Cooperating category vide press release dated September 20, 2024 on account of its inability to carry out a review in the absence of requisite information.
