Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 31, 2023, placed the rating(s) of Supreme Paper Mills Limited (SPML) under the 'issuer non-cooperating' category as SPML had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPML continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 15, 2024, September 25, 2024, October 05, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Supreme Paper Mills Ltd. (SPML) incorporated in July 1974, was promoted by one Todi family of Kolkata. SPML is engaged in the manufacturing of Printing and Writing Paper (PWP). The manufacturing facility of the company is located at Chakda in Nadia district of West Bengal. SPML primarily manufactures various types of papers which are creamwove, maplitho and azurelaid paper, along with converted paper. SPML markets its products under its flagship brand 'Supreme'. The company mainly operates in the domestic market with major focus in eastern India. The day-to-day affairs of the company are looked after by Mr. Raj Kumar Todi, Managing Director, with adequate support from other director- Mr. Dhruv Todi.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of SPML into ISSUER NOT COOPERATING category vide press release dated October 25, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
