Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 10, 2023, placed the rating(s) of Ganco Energy (india) Private Limited (GEPL) under the 'issuer non-cooperating' category as GEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 25, 2024, October 05, 2024, October 15, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Company

Ganco Energy India Private Limited (GEPL) was incorporated in the year 2014 and promoted by Mr. G. Appala Naidu and Mrs. G Chinni Kumarilakshmi. GEPL proposes to install 60 MW automatic Solar Photovoltaic (SPV) module manufacturing line at Bhemunipatnam, Visakhapatnam.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of GEPL to the 'issuer not-cooperating' category vide press release dated June 24, 2024 on account of its inability to carryout review in the absence of requisite information from the company.
