### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 20, 2023, placed the rating(s) of Shreenathji Cotton Industries (SCI) under the 'issuer non-cooperating' category as SCI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 04, 2024, September 14, 2024 and September 24, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the Firm

SCI was formed in 2004 as a partnership firm promoted by five partners. SCI is involved into the business of cotton ginning & pressing and primarily deals in cotton bales and cotton seeds. SCI operates with an installed capacity of 9252 Metric Tons Per Annum (MTPA) for cotton bales and 15,934 MTPA for cotton seeds as on March 31, 2020 from its sole manufacturing facility located at Anjar (Gujarat). SCI has other associate concerns known as Shree Krishna Cotton Industries and Shreenathji Oil Industries. Shree Krishna Cotton Industries, established in 2012 is engaged into manufacturing of cotton bales and cotton seeds, promoted by Mr. Shivji K Chhabhadiya. Further, Shreenathji Oil Industries is also an associate concern of SCI, promoted by Mr. Shivji K Chhabhadiya in 2005 as proprietorship firm engaged into processing of cotton seed for generation of oil.

**Status of non-cooperation with previous CRA:** CRISIL has continued ratings of SCI to 'Issuer Not Cooperating' category vide press release dated December 11, 2023 on account of its inability to carry out a review in the absence of the requisite information from the firm.
