Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated December 04, 2023, placed the rating(s) of R.K. Pharmaceuticals (RKP) under the 'issuer non-cooperating' category as RKP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RKP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 19, 2024, October 29, 2024, December 05, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
