### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 03, 2023, placed the rating(s) of Swagattam Plastics (SP) under the 'issuer non-cooperating' category as SP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 18, 2024, September 28, 2024, October 08, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the firm

Daman based SP, a partnership firm, was originally established in 2004 which was taken over by Mr. Anil Malviya and other partners in 2007. In 2011, the firm was reconstituted and is currently having two partners namely Mr. Anil Malviya and Mrs. Rekha Malviya having equal profit-sharing ratio. SP is engaged in Manufacturing of PVC Casting and Caping, PMMA Diffusers, PVC Profile, PVC Conduit Pipes, LED accessories and LED lights from its ISO certified manufacturing facility located in Daman. SP sells its products under brand name of: S-Lite and S Press.

**Status of non-cooperation with previous CRA:** India ratings has continued the rating assigned to the bank facilities of SP into ISSUER NOT COOPERATING category vide press release dated September 12, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
