### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 08, 2023, placed the rating(s) of Prateek Industries (PI) under the 'issuer non-cooperating' category as PI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 23, 2024, October 03, 2024, October 13, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the firm

Narsinghpur (Madhya Pradesh) based Prateek Industries (PI) is a proprietorship concern formed in November 2016 by Mr. Prakhar Sthapak. In April, 2017, PI was established with an aim for manufacturing and processing of Sugar, Jaggery, Jaggery Powder and Khandsari with total crushing capacity of 5500 Tons of cane per day (TCD) and is running at 70% of its processing capacity as on March 31, 2019. The plant facility of the firm is located in Narsinghpur district of Madhya Pradesh. It procures sugarcane from the local farmers of Narsinghpur. The project was completed in November 2018 and has started its commercial operation from December 2018.
