### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 26, 2023, placed the rating(s) of Schangalaya Motors (SM) under the 'issuer non-cooperating' category as SM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 10, 2024, September 20, 2024 and September 30, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Schangalaya Motors (SM), incorporated in September 2015 is an automobile dealer with its showrooms situated in Pondicherry, Cuddalore and Vilupuram. The day to day operations of the firm are managed by Shri. G R Durairaj and his wife Smt. R.D Durairaj. The firm is mainly involved in Auto Dealership of Mahindra and Mahindra Ltd.

**Status of non-cooperation with previous CRA:** CRISIL continues to categorize rating assigned to the bank facilities of SM under non-cooperation category vide PR dated July 24, 2024 on account of its inability to carry out a rating surveillance in the absence of the requisite information from the Firm.
