Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 21, 2023, placed the rating(s) of Rakesh Kumar Gupta Rice Mills Private Limited (RKGRMPL) under the 'issuer non-cooperating' category as RKGRMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RKGRMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 06, 2024, October 16, 2024, October 26, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

RKGRMPL procures paddy from farmers & local agents and sells its products through the wholesalers and distributors across 9 states in India and Nepal.
