Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 02, 2023, placed the rating(s) of Sabar Flex Industries (SFI) under the 'issuer non-cooperating' category as SFI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SFI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 17, 2024, September 27, 2024, October 07, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

SFI is engaged in manufacturing of packaging material like multilayer laminated wrappers, stand up pouches for all type of FMCG products, cosmetic products, automobile lubricant packaging, etc. SFI's manufacturing is located at Himatnagar. L.D. films are mainly used for manufacturing of printed bags and pouches which in turn find application as a packing material for salts, pesticides, insecticides and other agri-products.
