Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 21, 2023, placed the rating(s) of Power Spinning Mills (PSM) under the 'issuer non-cooperating' category as PSM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PSM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 05, 2024, November 15, 2024 and November 25, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

Power Spinning Mills (PSM) was established in March, 2003 by Mr. M Murugaswami, Mr. S P Saminathanin Mrs. Vijayakavitha and Mrs. R Vasanthi as a Partnership concern in Dharmavaram Tirupur, Tamil Nadu. The firm is mainly engaged in the manufacturing of cotton yarn. The firm manufactures cotton yarn with count range of 30s-40s.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of PSM into Issuer Not Cooperating category vide press release dated July 19, 2024 on account of its inability to carry out a review in the absence of requisite information.

Acuite has continued the rating assigned to the bank facilities of PSM into Issuer Not Cooperating category vide press release dated June 20, 2024 on account of its inability to carry out a review in the absence of requisite information.
