### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 19, 2023, placed the rating(s) of Utkal Metallics Limited (UML) under the 'issuer non-cooperating' category as UML had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. UML continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 03, 2024, September 13, 2024, September 23, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Incorporated in January 2003, Utkal Metallics Limited (UML) was promoted by Mr. Manjit Singh Panesar, Mr. Sarabjit Singh Panesar, Mr. Bipin Kumar Gupta, Mr. Ram Kumar Agarwal, and Mr. Hardeep Singh to set up a manufacturing plant for sponge iron. The company has started its commercial operations from November 2003 onwards and it has been engaged in manufacturing of sponge iron at its plant located at Rourkela, Odisha with aggregate installed capacity of 24000 metric tons per annum.

**Status of non-cooperation with previous CRA:** Acuite has continued the rating assigned to the bank facilities of UML into ISSUER NOT COOPERATING category vide press release dated January 11, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.

Brickwork has continued the rating assigned to the bank facilities of UML into ISSUER NOT COOPERATING category vide press release dated December 12, 2023 on account of its inability to carry out a review in the absence of requisite information from the company.
