### Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated December 15, 2023, placed the rating(s) of Shree Ganga Paddy Processors (SGPP) under the 'issuer non-cooperating' category as SGPP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGPP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 30, 2024, November 09, 2024, November 19, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
