Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 06, 2023, placed the rating(s) of B. Samyakk Agri Cottons (BSAC) under the 'issuer non-cooperating' category as BSAC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BSAC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 21, 2024, October 01, 2024, October 11, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
