Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 15, 2023, placed the rating(s) of Madhuri P. Rural Godowns (MPRG) under the 'issuer non-cooperating' category as MPRG had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MPRG continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 30, 2024, November 09, 2024, November 19, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Andhra Pradesh based, Madhuri P Padma Rural Godowns (MPRG) was established as a proprietorship firm in the year 2013 and promoted by Ms. Madhuri Pachimatla. The firm is engaged in providing ware house on lease rental to Telangana State Civil Supplies Corporation Limited (TSCSCL), Food Corporation of India (FCI) and Cotton Corporation of India (CCI). The property is built on a total land area of 10 acres and comprises of 4 godowns, with aggregate storage capacity of around 23000 MT, for food crops like rice, wheat, cotton etc respectively. Commercial operations for two godowns were started in November 2014 and for other two commercial operations started from July 2018.

Status of non-cooperation with previous CRA: India Ratings has continued the ratings assigned to the bank facilities of MPRG to the 'issuer not-cooperating' category vide press release dated December 13, 2024 on account of its inability to carryout review in the absence of requisite information from the firm.
