Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 11, 2023, placed the rating(s) of A.M. Rice Mills (ARM) under the 'issuer non-cooperating' category as ARM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ARM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 26, 2024, November 05, 2024 and November 15, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Karnal (Haryana) based A.M. Rice Mills (ARM) was established in 1986 as partnership firm by Mr. Anil Kumar Gupta, Mr. Ajay Gupta and Mr. Ram Prakash Gupta. In April 2011, Mr. Ajay Gupta and Mr. Ram Prakash Gupta retired from the partnership and Mr. Abhishek Gupta was admitted as a new partner. ARM is engaged in milling, processing and trading of both basmati and non-basmati rice at unit located at Karnal, Haryana.

Status of non-cooperation with previous CRA: BRICKWORK has continued the ratings assigned to the bank facilities of ARM into 'Issuer not-cooperating' category vide press release dated March 27, 2024 on account of non-availability of requisite information from the firm.

ACUITE has continued the ratings assigned to the bank facilities of ARM into 'Issuer not-cooperating' category vide press release dated August 09, 2024 on account of non-availability of requisite information from the firm.
