Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 23, 2023, placed the rating(s) of Eshyan Infratech (EI) under the 'issuer non-cooperating' category as EI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. EI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 07, 2024, September 17, 2024, September 27, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The firm is engaged in the civil construction work relating to road works, canal works, earth excavation, trench digging work, tunneling, pipe laying, construction of underground level water tank and overhead water tanks.

Status of non-cooperation with previous CRA: India Rating has continued the rating assigned to the bank facilities of EI into Issuer Not Cooperating category vide press release dated May 15, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.
