Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 13, 2023, placed the rating(s) of Satya Sai Exims (SSE) under the 'issuer non-cooperating' category as SSE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 28, 2024, November 07, 2024, November 17, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
