## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 22, 2023, placed the rating(s) of Shri Ram Comtrade Private Limited (SRCPL) under the 'issuer non-cooperating' category as SRCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 06, 2024, November 16, 2024 and November 26, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in December 2012, Shri Ram Comtrade Private Limited (SRCPL) was promoted by Mr. Abhishek Agarwal and Mr. Pinkey Agrawal of Ranchi, Jharkhand. Since its inception, SRCPL has been engaged in trading of construction materials like cement, iron & steel, different types of pipes and pipe fittings.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of SRCPL into Issuer Not Cooperating category vide press release dated January 17, 2024 on account of its inability to carry out a review in the absence of requisite information.
