## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 06, 2023, placed the rating(s) of Suman autos (SA) under the 'issuer non-cooperating' category as SA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 21, 2024, October 31, 2024 and November 10, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Later in 2003 the partnership deed was reconstituted and two partners Mr. Anil Kumar Garg and Mr. Amit Garg retired and a new partner Mr. Ashok Garg was admitted in the firm as partner. SA is an authorized dealer of Bajaj Auto Limited for two wheelers since 1998 and for three wheelers since 2003. The firm has three showrooms two at Noida (Sector-2 and Sector 58) and one at Greater Noida. All the showrooms are operating as 3S facility 'Sales, spares and service'.
